This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Town of Lancaster, said County, known as Erie, and described as follows:

CLOSURE:

That portion of Town Line Road (CR335) will be closed from Walden Avenue to Westwood Road to replace the cross culvert at 1120 Town Line Road. The closure will be on September 19th, 2018 starting at 8:00am and will reopen upon completion of work (approximately 4:00pm). Detour will be posted. The Erie County Clarence Maintenance Barn will be performing the work and can be reached at 716-759-8328.

This closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
