This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Town of Lancaster, said County, known as Erie, and described as follows:

CLOSURE:

There will be two daily bridge closures (8:00am until 3:30pm) between August 21, 2019 and September 9, 2019 for the purpose of deck washing and crack sealing. Only one of these bridges will be closed at a time. Buses and emergency vehicles will be allowed to travel through work zone. Hunting Valley will be performing the work. The bridges closures are as follow:

- Ransom Road (CR 155) between Cayuga Creek and Hall Road (BIN 3327050)
- Schwartz Road (CR 337) between William Street and Broadway (BIN 3327330)

This closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
