- i Beekeeping permitted provided that such activity is conducted in the rear yard and shall be kept 25 feet away from any lot line.
  - ii Common recreational structures or uses are permitted provided that: (1) the land is owned by a homeowners' association or other common ownership and is maintained and used only by the members of the association or owners in common, and their families and guests; (2) the members or common owners are residents of the subdivision within which the structure or use is located; and (3) all buildings shall be located at least 75 feet from any adjoining residential lot line, and all other structures and uses are at least 25 feet therefrom.
  - iii Custom manufacturing shops are permitted provided that the use does not produce offensive odors, noise, vibration, heat, glare, or dust.
  - iv Kennels and the keeping of small animals is permitted with the condition that any structures, pens or runways for the housing thereof are not less than 100 feet from any lot line. Further, no manure or other odor- or dust-producing substance shall be stored within 100 feet of any lot line. The manure shall be stored in tightly covered containers which shall control odor and insects.
  - v Seasonal fruit and vegetable sales stands requiring a structure shall require a building permit. Seasonal fruit and vegetable sellers, hawkers, or peddler-type use, including holiday-related sales, operated from a vehicle or trailers shall be required to obtain a license as required under Town codes.
  - vi The raising of livestock and/or poultry on lots of not less than five acres, and/or the raising of bees as permitted by the Code permitted provided that: (1) All such activities shall be conducted in an enclosure, and that fences or other enclosures shall keep the livestock, poultry or bees 15 feet from the lot line; (2) Any structures, pens or runways for the housing thereof shall be not less than 100 feet from any lot line; and (3) No manure or other odor- or dust-producing substance shall be stored within 100 feet of any lot line.
  - vii The roadside sale and display of agricultural products raised on the premises is permitted provided that the roadside stand shall not exceed 300 square feet in net floor area.

- viii In sewerred areas, R District provisions shall apply. Attached or built-in garages shall be deemed part of the principal structure, except for minimum livable floor area requirement.
  - ix Solar energy facilities are subject to all regulations and requirements of Article XI of Chapter 50 of the Town Code.
  - x Private and public stables are permitted provided that the area of the lot is five acres or more, and the stable and all exercise tracks are located at least 100 feet from any lot line.
  - xi Windmills for the pumping of water or production of electricity are permitted provided that tower shall be no closer than 150 feet to any property line and shall not exceed 100 feet in height.
